# A proposal to revise **Lay Ministry Training and Formation**From January 2026

### 1. Introduction

This paper presents a proposal to revise lay ministry training and formation from January 1st 2026.

The proposal has been developed by listening to those who are currently involved in the training process, and those whose ministry is impacted by it; these include members of the Vocation and Formation team and members of other Diocesan teams, 20+ incumbents, students from cohorts 14, 15 and 16, future students, a selection of tutors, a deanery chapter, a deanery synod and the Bishop's Management Group (BMG).

In making this proposal there is no intention to seek change for the sake of change, rather to ensure that lay ministry training is meeting both the needs of students and the parishes and benefices they minister in.

#### 2. Context

### **Course content**

The current lay ministry training course is shaped as a traditional introduction to systematic theology. It was designed around nationally agreed learning outcomes in place in 2016/7 which were significantly revised in 2021 and published in September 2022 as the Reader Formational Framework. It has operated, largely unchanged, for the past decade.

The course is delivered using a face-to-face model consisting 72hrs of contact per year, comprising weekend residentials, study days and six x 2hr modules, usually delivered at Bouverie Court and commencing at 7.30pm. (Appendix 1) With the exception of a small number of diocesan officers all tutors are volunteers and offer their services free of charge.

Licenced Lay Ministers train for two years and Readers for three years.

### **Students**

The current student number is 34, all progressing through training as aspirant lay ministers/readers. Students are exploring the call to serve pastorally, evangelistically or as Readers. The average cohort of students is between 10 and 15, with ages ranging from 28-70 and varying prior experiences of education. An increasing number are neuro diverse.

The diocesan team supporting lay ministry training have responded to the increase in neurodiversity by implementing informal pastoral support plans for students. These have had some success, and individual feedback is good. Currently 11/35 students have some form of pastoral or academic support plan in place or in preparation which, where appropriate, is shared with their incumbent.

The current course had a periodic evaluation review in 2022 and a follow up visit in 2023. It is not linked to any theological college or academic institution.

Feedback from students and incumbents is variable. It varies from consistently good to feedback which has raised concerns about teaching methodology, training venues and some of the course subject matter.

### 3 Feedback

Feedback on the current provision for lay ministry training and formation has been sought and received through discussion and by direct observation. It can be summarised as follows:

- There needs to be more routes into lay ministry, some of which are shorter and more focussed.
- Training needs to reflect contemporary training methods (online as well as face-to-face).
- Training venues need to be better distributed across the diocese.
- Training and formation need to be more accessible, reflecting the increase in students with limited prior educational experience and those with neuro-divergence.
- Means of assessment are too focussed on written assignments or partially written content.
- Consideration needs to be given to the balance between training and formation.
- Consideration should be given to the balance between systematic theology and contextual theology.
- The course should retain its rigour.
- Students value the passion and expertise of their tutors.
- Students should continue to have access to communities of learning which support their formation as lay ministers.
- Students should be given access to a broader range of theological viewpoints on key issues.
- More time needs to be devoted to ministering in specific contexts (eg rural benefice, urban deprived).
- Preparation for ministry omits key essentials such as conflict resolution, mediation, sitting alongside those who hold differing beliefs.
- Post licencing training needs to be improved and integrated into other ministry training.
- Students should be given the opportunity to learn about differing faiths.

### 4 The Proposal

### Rationale

Widen accessibility to lay ministry training, so releasing those being called by God having been effectively formed for ministry.

# **Executive Summary**

The proposals, when adopted, will introduce

- The role of Authorised Lay Minister for those seeking to undertake pastoral or evangelistic ministry or lay chaplaincy, ministering alongside the current role of Licenced Lay Minister (Reader).
- A hybrid model of training and formation with teaching bases across the Diocese.
- A more accessible entry point to studying theology.
- Enhanced levels of integration between formation and training.
- A course fully aligned to the Reader Formational Framework (2021) which prepares lay ministers for ministry in the context to which they are called.
- Embedded academic mentoring (subject to funding) for up to eight students a cohort.

- Maintain the rigour of the current course, having an emphasis on good quality teaching delivered in pastorally sensitive learning communities.
- Increased accessibility for those prospective students who are neuro-diverse or who have limited prior educational experience.
- Compulsory CMD for Readers on the revised course.

### In addition:

- The first cohort of the new training course will be based in Peterborough for face-to-face study days with a second cohort being located in Northamptonshire if there is sufficient demand.
- All tutor roles for the revised course will be advertised across the diocese in the autumn term of 2025.
- Authorised Ministry specialist units will be drawn from existing practical units with additional units being released from Year 2 onwards.
- All course material will be reviewed for 3 years, to ensure it is fit for purpose and meeting the needs of students, parishes and PER.
- Existing students will remain within their current course structure.

# Course design and curriculum

### Vision

Our vision is to release lay ministers into service who can use their God given talents to share the good news of Jesus Christ. This requires bravery to take what we have in place and re-imagine it. To bring into a being a programme of discernment, training/formation and post licencing support (CMD) that increases the number of people coming forward to explore the call of God in their lives and to form them in a way which enables them to flourish in ministry.

### Proposed revised structure (Appendix 2)

# Authorised Ministry Proposed Units (Appendix 7)

These specialist units will initially utilise the practical modules contained with the current lay ministry course and will include standalone courses, e.g. pastoral care, evangelism, chaplaincy and preaching.

### Means of delivery

Courses will, intentionally, be more formational in nature. They will be representative of all church traditions.

Delivery will be hybrid with face-to-face study days held on Saturdays.

A model of theological reflection will be used throughout all courses.

All Authorised level courses offered by the Diocese will, ultimately, be of the same academic level with similar assessment methodology.

### Content

Themes have been drawn from the existing course and from the Reader Formational Framework (RFF). The aim has not been to replicate current provision, rather integrate the feedback received with the learning outcomes contained within the RFF and the existing strengths of the lay ministry course.

Outline programmes of study and draft module descriptors can be found in the appendices as follows:

Appendix 1: Introduction to Theology – a broad overview of key theological concepts.

Appendix 4: Introduction to Reader Ministry (Y1) - in depth theology, practical aspects of ministry.

Appendix 5: Introduction to Reader Ministry (Y2) – teamwork, leadership, teaching/ nurturing

the faith.

Means of assessment (Introduction to Theology - Year 1)

Term 1: 30-minute discussion with Tutor.

Term 2: 10-minute verbal presentation to a small group.

Term 3: Presenting a short action plan for next steps in ministry, responding to questions (15 mins)

Final assessment: 1500-word reflection of what has been learnt over the year, how it will affect ministry in the student's local context and what God is now calling them to. This can be written or recorded.

Means of assessment (Reader training -Year 2)

Combination of assessment methods depending on student need.

Means of assessment (Authorised training -Year 2)

Combination of assessment methods depending on student need.

Means of assessment (Reader training - Year 3)

Combination of assessment methods depending on student need.

Personal Development Outcomes will be assessed separately throughout the course (Appendix 6)

### **Discernment**

Discernment will occur prior to, and throughout, the lay ministry course. Application to join the course will commence through the completion of an online application form which will be followed by an initial meeting with a Vocations Adviser. On commencement of the 'Introduction to Theology' course discernment discussions will continue to determine whether an Authorised or Licenced Lay Ministry pathway will be followed In Y2 or Y2/3.

### Pastoral and Formational Care

Training and Development activities (the core curriculum) will be undertaken alongside 'Practice Groups' which meet monthly online to theologically reflect on what is being learnt and experienced and to provide prayerful pastoral support. Each group will be led by an experienced facilitator.

Each group will consist of no more than five students with a group facilitator. The groups will meet across the three years of training and will become a significant part of the spiritual formation journey. It is hoped that the groups will continue to meet once readers are licenced as part of any ongoing spiritual formation.

### Academic mentoring

It is hoped that up to eight students per year will be able to access mentoring from academic mentors.

Mentors will be appointed and trained from within the diocese by external trainers. This aspect of the proposal is subject to a successful funding bid to the Resourcing Ministerial Formation Innovation Fund.

### 5 Conclusion

Change is never easy. It requires the ability to see things as they are, with both strengths and weaknesses visible, and how things could be. This proposal is not perfect and will be subject to a process of continuous review, however, I am confident it reflects the current position within the diocese and the shared desire to see people who are called by God being released into ministry, confident in their ability to serve.



### **Personal Development Outcomes**

These outcomes will form a central part of the individual's spiritual formation as they progress through the course.

If following a licenced pathway, greater depth will be observed within the Year 2 programme of study, and the compulsory continuing ministerial development which will occur within the first year of licenced ministry.

### **Love for God**

The student:

- Is rooted in established patterns of corporate worship, Bible reading, prayer, study and reflection
- Relates their prayer and worship to the world of home, work and society
- Is enthusiastic and open about developing their understanding and practice of a range of approaches to Christian spirituality

### Love for the World

The student:

- Has a call to serve in this ministry that is recognised and affirmed by others
- Shows personal understanding of their gifts for lay ministry
- Is informed and realistic about the costliness and impact of being in public ministry

### **Love for People**

The student:

- Is a person of openness, stability and self-awareness
- Can nurture themselves while caring for others
- Can recognise, understand and seek to address their own biases

### Wisdom

The student:

- Shows personal integrity, emotional maturity and honesty
- Makes good use of feedback, receiving it well and using it to identify areas of strength and areas for development

### **Fruitfulness**

The student:

- Sustains their own resources and energy through good self-care and nurture
- Can recognise, use and develop their gifts and strengths, and understand and mitigate their vulnerabilities
- Models' humility

 Resources themselves through good self-care and maintains a breadth of interests to enable flourish and growth
