Parenting Through Adversary - Foundations

Foundations has recently released a practice guide for working within the National Framework for Children's Social Care. The framework is aimed at the leadership, workforce and multi-agency groupings, within the children's care sphere. The guide aims to support the delivery of key principles and recommendations of the national framework. The guide is evidence based and looks at how best to support children aged 0 – 10, within situations where adverse circumstances can undermine parental support. These adverse circumstances can be those such as poverty, substance misuse, partner violence, couples conflict and parental mental health challenges. Official Data Trends - Centre of Expertise on Child Sexual Abuse

The Centre of Expertise on Child Sexual Abuse has released their report on trends from 2023/2024. Their reports are annual and focus on the collation of data from the previous year. Their latest report has identified a decline in child sexual abuse reported to children's services in that period. Their analysis shows that despite this news, the number of people charged and convicted following child sexual offences increased. In addition, the number of children coming under a protection plan fell to its lowest level in thirty years in England. As of December 2024 only 3.5% of new protection plans are related to child sexual abuse. Child sexual abuse is also being detected less, with the number of assessments

reaching a record low. Based on their report, the Centre of Expertise on Child Sexual Abuse estimates 500,000 children will experience sexual abuse every year. The report makes for compelling reading, to find out more please follow the link below:

Cybercrime and Harms - Russell Webster

Advanced technology has increased the breadth, scale and sophistication of cyber crime. The question of how can cyber security evolve to counter this advance, has now become mainstream. In Autumn last year, the Parliamentary Office of Science and Technology published their report on cyber crime and online harms. The report was based on a horizon scan consultation of researchers, which revealed significant expansion in the landscape of cyber-crime. Concern has come to centre around: online bullying, assault, cyberstalking, coercive control, the spread of disinformation and radicalisation. More entities than ever have been

gaining unauthorised access to digital devices or networks. As a result the potential to commit fraud or collect and leverage confidential data to extort money has increased. Entities working in this sphere include organised crime, foreign states and foreign aligned groups. Russell Webster has published a summary of the report's findings.
