



## Safeguarding Briefing - 13th May 2024

### Critical Incidents

The government has recently published a new guidance document helping schools to prepare for serious incidents. Although schools are often encouraged to consider potential threats from external sources, two recent serious incidents in south Wales and Sheffield remind us that threats can come from inside the school too.

Whilst no-one would want to stress pupils by involving them in an exercise, especially younger children, it is important that senior leaders perhaps consider a 'walk through' of a serious scenario. It is also useful to consider asking the 'what-if-it-happened here' question after an incident which has been reported in the media.

## **Security Minded Communications (National Protective Security Authority)**

### **Could you be giving away too much information on your website or social media pages?**

Thinking about critical incidents, cyber-security and personnel safety, it is worth thinking about how the sharing of detailed information about your school could inadvertently put people at risk.

Some years ago at a school I was associated with the estranged partner of a school governor managed to trace her whereabouts as a result of the information the school had posted about their governing body. The person waited outside the school to attack the woman after a meeting. She thought she had made it difficult for her ex-partner to trace her, not least by avoiding using social media herself. However, the school published a list of governors and their photographs on its website, along with sufficient detail in each person's biography for the attacker to confirm that was his ex-partner. A calendar of meeting dates and times ensured that the ex-partner knew when she would be there, even though he didn't know her home address.

The National Protective Security Authority (NPSA) is the UK government's technical authority for physical and personnel protective security. The NPSA says, 'Educational settings are places that are

typically thought to be welcoming and safe. However, they may also be a viable target for a hostile act.'

'The guidance [document] provides information on the concept of Security-Minded Communications, which should be considered when publishing information for the public.'

For example:

Look through the information that you have already put in the public domain, or information that you plan to share soon, and check you are not accidentally gifting information of use to a hostile.

You could consider the use of mailing lists to ensure you have control over who receives the most detailed information about your setting. Avoid providing detailed and direct contact details for people which may help a hostile undertake a 'spear phishing' attack.

### Filming near school gates (LGfL/Islington Council)

Katy Potts, Computing, Digital and Online - Lead for schools at Islington Council writes:

Islington Council and the London Grid for Learning are currently working with schools on a pilot campaign to stop filming near school gates.

Filming outside the school gates can put adults and children at risk by showing the name of the school, its sign and the school uniform. Some children may have been adopted, families may have moved from across the country to escape crime.

Many schools already have robust phone and filming policies for pupils, and now Islington Council have partnered with LGfL to support schools to update these policies to include No Filming, including for the wider community and media.
