

Rethinking Masculinity and Mental Health - Harmless

In male culture showing emotion, crying for example, is seen as a relative taboo. Other outpourings of emotion; anger, sadness or seriousness, is generally discouraged. However, this creates a restrictive environment for males and breeds into their relations, a prohibitive social expectation over emotional engagement. The penalties for breaking this taboo can be bullying or physical abuse within intra-male relations. Psychologically this produces harmful mental effects that can impinge on development and social relations. The current educational emphasis on mental health, emotional wellbeing and suicide awareness, can be daunting to staff. The issues are complex and without sufficient background knowledge the concern may be justified. The Papyrus organisation has recently developed the 'Sinking Feeling Schools Resource' to address this issue. Their new resource targets students from year six to year thirteen, and hopes to enhance PSHE in schools. Question of the Week

Question: What is the minimum age for marriage in England and Wales?

Answer: The legal minimum age for marriage or civil partnership in England and Wales is 18.

This change came into force on 27 February 2023 under the Marriage and Civil Partnership (Minimum Age) Act 2022, and there are no exceptions: marriages involving anyone under 18 are void, and arranging them is a criminal offence. (Previously, 16- and 17-year-olds could marry with parental consent.)

The law also covers marriage ceremonies that are not legally binding, such as those carried out in community or traditional settings. It applies whether the ceremony takes place in England and Wales or abroad, as long as one or both of the children are habitually resident in England and Wales. This provision was introduced to prevent families from taking children overseas to bypass UK law by arranging underage marriages.

The legislation enhances the protection of vulnerable young people by criminalising all actions that lead to child marriage. A conviction carries a maximum sentence of seven years in prison.

If staff hear of a child under 18 getting married, they must treat it as a safeguarding concern and report it immediately to the DSL.

(Note: different rules apply in Scotland and Northern Ireland.)

Chatbots and Children - The Children's Society

The social media sphere has recently gained a new tool in their battle for youth engagement - the chatbot. Chat bots are not particularly new, but the sophistication of their governing algorithms is. These applications are designed to keep people engaged with artificially generated responses. Responses formulated based on the information the user puts into them. This can create a self-reinforcing effect, where the chatbot continually increases the user's convictions in the truth of their own inputs. False information, reinforcement of poor choices and self-manipulation are common issues with this emerging software.
