### Support Guidance for Student Image Security - UK Safer Internet Centre

Appropriately managing images and videos on a school website is essential to maintain a professional and secure online presence whilst mitigating opportunities for misuse. Ensuring that media is carefully selected, appropriately captioned and compliant with local policies helps to protect pupils, students and staff against unauthorised sharing or manipulation.

Clear expectations, consent procedures and thoughtful content curation are vital in promoting your organisation's values, celebrating success and engendering trust within the community. By managing content responsibly, schools, colleges and other organisations can effectively showcase achievements whilst mitigating potential risks. The question is how to do this properly? The UK Safer Internet Centre has the answer.

### Countering Financially Motivated Sexual Extortion - CEOP

The criminal practice of extorting individuals on the pain of releasing self-explicit material is commonly known as 'sextortion'. The practice's technical name 'Financially Motivated Sexual Extortion' or FMSE, is an increasingly prevalent form of child sexual abuse. What started as simple

money exchanges, now include cryptocurrency seizures and pre-paid gift cards as forms of criminal redemption.

Males aged 14 to 17 are overwhelmingly represented in cases of this nature. Often they'll be enticed by the promise of seeing sexually explicit images, before the rug is pulled and the scam put into operation. As a result the victims have been tricked or groomed over a period of time. With the rise of AI this practice is becoming more complex with false explicit images actually changing hands, in exchange for a real image of the target. CEOP is highly concerned with this practice and has authored a guide page on what to do. If interested, please follow the link below:

## Question of the Week

If a child tells you something concerning about another pupil but asks you to ‘promise not to tell,’ how should you handle it?

**Answer:** Even if the child is sharing a concern *about someone else*, you should never promise to keep it a secret. The fact that the concern is about another child does slightly shift the emphasis, but not the core principles. You might say: “*Thank you for telling me. I can't promise to keep it a secret, because I might need to share it with someone who can help. But I'll only tell the people who need to know.*”

Key points:

- Reassure the child that they've done the right thing by speaking up.
  - Avoid pressing for more information or asking leading questions.
  - Be clear that your role is to help keep everyone safe—not to keep secrets.
  - Record what was said accurately and report it to your Designated Safeguarding Lead (DSL).
  - Whether the concern is about themselves or another pupil, your role is always to listen, reassure, and report.

## Good Childhood Report Analysis - CPOMS

CPOMS have produced an analysis of the 2024 ‘Good Childhood Report’ complied by the UK Children’s Society. The society has been undertaking annual surveys from 2009, so have an excellent data set to examine emerging trends. Many of the data sets have a direct impingement on the sphere of safeguarding. The report’s data covers both schools and FE colleges covering a large age bracket of 10 to 17.

General trends in the welfare and wellbeing of young people in the UK can be formulated as a result. The 2024 report has covered 2,000 pupils aged 10 to 17, but also includes data coming from parents and carers. The report’s data sets were drawn from three key sources, the UK Longitudinal Household Survey from ‘The Understand Society’, the Children’s Society’s own annual household survey and PISA.

The PISA component, which also surveys this age group in Europe permits comparative data sets between the UK and EU states. To read all

## Safeguarding Online Safety Audit - London Grid for Learning

The current Keeping Children Safe in Education guidance states “schools and colleges should consider carrying out an annual review of their approach to online safety”. This should be led by the designated safeguarding lead because they “take lead responsibility for safeguarding and child protection (including online safety and understanding...filtering and monitoring...)” (KCSIE 2024). It is for this purpose that the London Grid for Learning, has created an audit tool to aid educational establishments. The document comes in an editable and downloadable format, following .doc. In the document you can find questions to apply a RAG rating to and add your own evidence and action points. It is a well thought out approach to the topic and well worth a look.
