## Question of the Week

### Thinking about staff behaviour, what is the difference between an allegation and a low level concern?

An **allegation** is where anyone working in a school or college (including supply teachers, volunteers and contractors) has:

- behaved in a way that has harmed a child, or may have harmed a child and/or
- possibly committed a criminal offence against or related to a child, and/or
- behaved towards a child or children in a way that indicates he or she may pose a risk of harm to children, and/or
- behaved or may have behaved in a way that indicates they may not be suitable to work with children (this includes behaviour that may have happened outside of school or college)

A '**low-level**' **concern** does not mean that it is insignificant. A low-level concern is any concern – no matter how small, and even if no more than causing a sense of unease or a 'nagging doubt' - that an adult working in or on behalf of the school or college may have acted in a way that is inconsistent with the staff code of conduct, including inappropriate conduct outside of work .

'Low-level' concerns are behaviours that might not meet the harm threshold. Such behaviour can exist on a wide spectrum, from the inadvertent or thoughtless, or behaviour that may look to be inappropriate, but might not be in specific circumstances, through to that which is ultimately intended to enable abuse.

### What should staff do when they have any concerns about the conduct of a member of staff, whether they might be above the threshold or not?

*Inform staff of your organisation's policy on managing allegations and raising low level concerns, in particular remind them of the specific procedure to use and the names of people to whom reports should go.*
